2. SPONSORSHIP

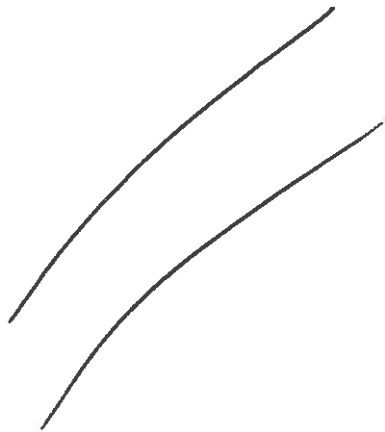
8. **OTHER INTERESTS**

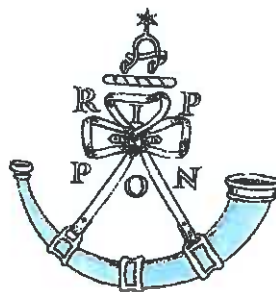
