17-16	<p><b>Disposal of Claro and Deverell Barracks</b></p> <p><i>With the permission of the Mayor, Cllr McHardy, it was agreed that this item be considered immediately after representations from members of the public (item 14-16).</i></p> <p><b>a) Announcement of disposal of barracks, as per letter to Julian Smith dated 18<sup>th</sup> January 2016.</b></p> <p>It was noted that the City Council has obtained a copy of the letter received by Julian Smith confirming the disposal of the Claro and Deverell Barracks sites in Ripon. The letter advises that the aim is to provide a small more sustainable estate in support of Military capabilities and that the work will contribute to the Government’s commitment to release public sector land for house building. The letter also advises that neither site will be disposed of before 2017.</p> <p><b>b) To note emerging City Plan approach in respect of redevelopment of barracks site (as considered at City Plan Committee meeting on 17<sup>th</sup> November 2015).</b></p> <p>Members considered a report from the City Development Manager outlining the detailed approach being proposed in the City Plan in respect of proposals for the redevelopment of the barracks.</p> <p>Councillors who are members of the City Plan committee confirmed that the draft Plan contains policies which should address a number of the concerns raised by other Councillors and members of the public.</p>
